## Welcoming Remarks and Adoption of 2021 Meeting Minutes - Board Chair, William Pedone

The Board Chair opened the meeting by welcoming all participants and thanking all for supporting the work of the MPBID throughout the year, and for advocating for the needs of the commercial corridor. ## 2. State of the District & MPBID FY21 Annual Report - Executive Director, Camelia Tepelus

The Executive Director made a presentation of the overall status of the commercial corridor, by reviewing the major programs of the BID in FY21, including the start of the horticulture and beautification program, a new Avenue NYC grant, and conducting a community outreach program addressing food vulnerability in Morris Park. An overview of the FY 21 financial statements was provided. Participants were directed to the FY21 Annual Report that was distributed and posted on the website for further details and information.
